2 Overview of this procedure

2.1 Purpose of this Market Procedure

This Market Procedure is intended to outline the procedures that a Market Participant will follow to submit claims, and the data necessary to support such claims for cost recovery following the re-dispatch of a Market Participant's generator or generating facilities.

2.2 Authority for Market Procedures

This Market Procedure is established in accordance with paragraph 4.3.7 and section 5.4 of the Nova Scotia Wholesale Electricity Market Rules and Published by the NSPSO in accordance with paragraph 1.5.1.1 of the Market Rules.

2.3 Scope and Application

As established in section 5.4.1 of the Market Rules with the inclusions and exceptions noted in that section, this procedure applies to Market Participants for Generating Facilities that are required to adjust their schedule including in the Day Ahead in order to address transmission constraints.

3 Process Description

3.1 Re-dispatch Up

3.1.1.1 Following any event of Re-dispatch up, the Market Participant may at any time prior to the end of the month following the event, submit a claim for Re-dispatch settlement to the NSPSO.

3.1.1.2 Any such claim shall be in accordance with the rules established in sections 5.4.2 and 5.4.3 of the Market Rules and must be supported by data setting out the actual variable fuel and operation and maintenance cost per MWh for the facilities that were re-dispatched, or the opportunity cost of compliance with the Re-dispatch instruction for hydro facilities. Supporting data shall be submitted using form MPF-13-01, and may include reference to previously filed cost information.

3.2 Re-dispatch Down

3.2.1.1 Following any event of Re-dispatch down, the NSPSO shall determine the Re-dispatch settlement amount, and shall submit a claim for Re-dispatch settlement prior to the end of the month following the event.

3.2.1.2 Any such claim shall be in accordance with the rules established in sections 5.4.2 and 5.4.4 of the Market Rules. NSPSO may require the Market Participant to submit data setting out the actual variable fuel and operation and maintenance cost per MWh for the facilities that were re-dispatched, or the opportunity cost of compliance with the Re-dispatch instruction for hydro facilities. Supporting data shall be submitted using form MPF-13-01, and may include reference to previously filed cost information.

3.3 Settlement

3.3.1.1 Any Market Participant required by the NSPSO to submit data as noted above shall do so within 10 business days of the request.

3.3.1.2 Payment by either party is due on the last Business Day no more than twenty (20) Days after the date of the issue of the claim, or on the last Business Day no more than twenty (20) Days after the date of the issue of supporting data, whichever is the later.

3.3.1.3 Claims or payments by Market Participants shall be addressed to NSPSO in care of the contact person noted in section 1.2 of this Market Procedure.

3.3.1.4 Settlement amounts will be calculated following the rules established in sections 5.4.3 and 5.4.4 of the Market Rules.

4 Dispute Resolution

4.1 General

4.1.1.1 Where a Market Participant does not accept a decision made by the NSPSO the Market Participant may initiate a review under the Dispute Resolution Process set out in Sections 5.8.3 and 2.8 of the Market Rules.
